

## **Fairview Twp. Reorganization Meeting – January 6, 2025**

Mr. Iorio will open the meeting with the Pledge of Allegiance.

Motion to make the following appointments:

Appoint Michael Iorio as Vice Chairman of the Board of Supervisors for 2025.
