Chairman Barry Jacob called the meeting to order at 6:32 pm.

Present: Barry Jacob, Michael Iorio, Harry Zearfoss Jr., Secretary/Treasurer Abby Wasiakowski and Solicitor Donald Karpowich.

Mr. Jacob asked if there were any comments on agenda items only. There were none.

Mr. Jacob made a motion to accept Ordinance 12-3-24 amending the salaries and compensation of Supervisors voted in after 12-1-2024 in the amount of \$262.08 per month, seconded by Mr. Iorio. All voted aye.

Mr. Jacob made a motion to accept the 2025 budget, seconded by Mr. Iorio. All voted aye.
